WELCOME, APOLOGIES, MEMBERSHIP

Ron Kemp, Facilitator, welcomed attendees to the meeting and the above apologies were noted.

2. MINUTES OF THE PREVIOUS MEETING

2.1 The minutes of the previous meeting held on 26 March 2009, were accepted as a true and accurate record of the meeting.

Moved Frank Mofflin - seconded Ann Prince. AGREED.

2.2 Matters Arising

From the minutes:

- Bob Cooper has confirmed that he will be the community representative from the CIF Executive on the NRG.
- Complaints proformas these have been received from Nick Jones and will be passed to Allan Gade.
- The city of Rockingham has issued a purchase order to KIC for their contribution to the noise mnonitoring.
- It was noted that Allan Gade had not yet contacted Peter Knol at the DEC to discuss the use of the 'yellow brick'. Peter advised that this tool can be used to record levels and noise and has a 2 to 4 hour digital tape which is sent to a laboratory to be analysed. There are currently delays

at the laboratory. It was reiterated that all noise complaints must be directed to the DFC.

From the Action Plan:

- The proposal has been updated and will be discussed under agenda item (5).
- Chris Oughton and Paul Drew to discuss the verification of the model.
- KIC will contact members for details of any unplanned activities during the noise monitoring.

3. TERMS OF REFERENCE

Following a discussion at the last meeting, the Terms of Reference were updated with feedback and comments for endorsement.

Moved Ann Prince - seconded Frank Mofflin. AGREED.

4. NEW ISSUES TO BE NOTED

Allan Gade was unable to attend the meeting, however prior the meeting he had sent information to KIC to be discussed at the meeting. Allan believes that the noise monitoring can be carried out outside the April/May period as suggested by Paul Drew. Paul previously suggested that in Summer people can be subjected to more noise as they would have their windows open, however winter is also very important especially in the southern section. Perhaps the noise monitoring should be carried out on more than one occasion.

Paul responded that he had suggested April/May because of the high pressure systems which are good monitoring conditions. There are three aspects to the monitoring:

- 1. Verfication of model need low wind conditions.
- 2. Monitoring to identify source of complaints. Measurements of levels may identify source or may not. Complaints have been intermittent.
- 3. Look to see what the noise of concern is and do some measurements.

Members agreed it would be good to compare results with previous results to show a comparison in noise levels and also identify the improvements made by industry to the community.

5. PROJECT PROGRESS REPORT - PAUL DREW, HERRING STORER

5.1 Complaint-based Noise Monitoring

It was previously agreed that Paul is available for call-out to complaints. Monitoring may indentify and determine the source.

5.2 General Noise Monitoring

Item Action

Suggest two weeks monitoring and carry out when complaints are occurring.

5.3 Model Verification

Suggested that it includes spot measurements in the KIA, both directional and fixed monitoring. Paul was asked to identify and recommend appropriate reference locations that could be used on a regular basis to provide comparative data over time. Agreed to discuss further at the next meeting.

It was noted that NRG members agree with the scope provided by Paul Drew, although the emphasis and timing has changed. Paul to update the scope to include identified reference points. The integrity of the scope has not changed it will now also include recommendation of reference spots. Endorsement of the reference spots will be required from the NRG, particularly community members.

6. ANY OTHER BUSINESS

6.1 Noise Levels at BHP Billiton

Ann Prince, on behalf of Allan Gade, made reference to elevated noise levels at the east and north boundaries of BHP Billiton. Frank Mofflin confirmed that he had spoken to Allan Gade about this and encouraged Allan to contact BHP at any time to discuss these issues.
